OTTAWA, ONT, JUNE 1ST 2023. C&E Intellectual Solutions with some of its clients, injured workers are speaking out about how injured and disabled workers are being treated and undermined by the various WCB Boards and the WSIB across the country.

Founder and CEO of C&E intellectual Solutions Rae Banwarie, a retired RCMP veteran officer of 20 years who with his team led the charge and unionized the RCMP with a win at the Supreme Court of Canada in January of 2015, is speaking out on this significant issue which impacts millions of workers in Canada. Banwarie will be speaking out alongside injured workers and first responders about how the various WCB Boards and the WSIB Board are dealing with disabled workers and the treatment they and their families are receiving.

- Speaking from a policing perspective and as the previous National President of the Mounted Police Professional Association of Canada (MPPAC), Banwarie, principal for C&E Intellectual Solutions Corp will be bringing potential viable solutions for improvements for the WCB program's national wide, along with a proposal for improvements for legal assistance for injured and disabled workers. Banwarie wants to meet and discuss these issues with the Federal Labour Minister, Honourable Seamus O' Regan Jr, and the Honourable Minister of Justice David Lametti.
- Appearing to speak about his experiences with the WSIB is a retired award winning veteran firefighter of 27 years - Fire Services Exemplary Service Medal Award recipient - Norman Traversy. Traversy was also firefighter of the year in 1999 in Mississauga and a respected firefighter until his injury. Traversy's story is one of endurance and staying the course for justice.

- Appearing to speak about her experiences with the Sask WCB is retired veteran Regina Police Service Officer of 20 years, Heather Gray. Gray was the first female Hostage Negotiator, a Detective in the first Forensic Child Abuse unit, and recipient of three commendations, two for bravery. Heather was instrumental in bringing in training with the LA PD tactical Unit and the FBI. Gray's story is one of resilience and never giving up.
- Appearing to tell his story and his experiences with the BC WCB is retired professional driver for over 30 years and licensed pilot, George Kavallis. Kavallis like many workers in Canada became injured in the workplace. Kavallis sought assistance and the care that he was entitled to and deserved under the professed mandates from the BC WCB but his case was dismissed by the BC WCB. The BC WCB's failure to support and care for him continues today.

C&E Intellectual Solutions Corp will continue to investigate, advocate and represent its clients on this significantly important matter which impacts millions of workers and their families in Canada.
